**ORDER CONDITIONALLY APPROVING DISCLOSURE STATEMENT AND FIXING
TIME FOR FILING ACCEPTANCES OR REJECTIONS TO THE PLAN OF
REORGANIZATION COMBINED WITH A HEARING NOTICE THEREOF**

The Disclosure Statement under chapter 11 of the Bankruptcy Code having been filed by the Debtors on November 3, 2010, (Dkt. # 123) and the Plan of Reorganization under chapter 11 of the Bankruptcy Code filed by the Debtors on November 3, 2010, (Dkt. # 124); and the Debtors being, and having elected to be considered a small business; and the Court having determined that the Disclosure Statement contains adequate information pursuant to 11 U.S.C. Section 1125:

IT IS ORDERED, AND NOTICE IS HEREBY GIVEN THAT:

- (1) The Disclosure Statement is conditionally approved.
- (2) The 3rd day of **December, 2010** is fixed as the last day for filing written objections to confirmation of the Plan.
- (3) The 3rd day of **December, 2010** is fixed as the last day for submitting ballots of acceptance or rejection of the Plan with the attorney for the Debtors. (Address of Debtors' attorney: James Ray Mazingo, Knight Mazingo & Quarles, PLLC, 601 Renaissance Way, Ste. B, Ridgeland MS 39157)
- (4) A Hearing on Confirmation of the Disclosure Statement (if written objections have been timely filed), and a Hearing on Confirmation of the Plan will be held on **December 21, 2010 at 1:30 P.M.** in the **U.S. Bankruptcy Courtroom, Room 106, 100 E. Capitol Street, Jackson, Mississippi.** Testimony will be taken. Witnesses should attend.
- (5) The attorney for the Debtors shall cause to be mailed to each creditor, the United States Trustee, and other parties in interest a copy of the following:
 - (A) This Order;
 - (B) The conditionally approved Disclosure Statement filed November 3, 2010;
 - (C) The proposed Plan of Reorganization filed November 3, 2010; and
 - (D) A ballot form for voting on the acceptance or rejection of the Plan, **which should be returned to the Debtors' attorney and not the Court.**

- (6) This mailing shall be completed within **five** (5) days from the date of this Order.
- (7) The attorney for the Debtors shall file a Certificate of Service with the Court, listing the name and address of each party served, immediately after the mailing of this Order with the enclosures specified herein.
