RE: DISCONTINUE REPORTING BANKRUPTCY CASE FINANCIAL
STATISTICS (**ACTION REQUESTED - Effective June 1, 2008**)

Following a recent review by statistical data stakeholders, we have determined that, effective with bankruptcy cases closed June 1, 2008, or later, there is no longer a need for clerks' office staff to enter into CM/ECF or transmit financial receipts and distributions statistical data captured at case closing in asset cases for all chapters. **Therefore, beginning June 1, 2008, clerks' office staff no longer need to complete the fields in the attached CM/ECF screen.**

The attached statistical reporting screen is the only screen affected. Some fields in the screen may be pre-populated or otherwise contain data, but the attached screen can be ignored. All other statistical reporting requirements remain unchanged.

In Release 3.3, planned for late summer 2008, the screen will be eliminated, but there is no reason to wait for the software update to make this procedural change. In addition, the updated Statistical Reporting Guide that we plan to post this summer will be updated to reflect this change.
