Local Rule	Page	Summary
1001-1(c)(d)	10	Technical - Update effective date of adoption of original local rules and the latest amendments.
3007-1(a)(2)	19	Requires a party objecting to a claim to deliver the hearing notice to the affected. <i>(See Page - Noticing Process)</i>
3015-1(b)	20	Requires <u>all</u> chapter 13 plans filed by or on behalf of the debtor be typewritten.
5005-1	28	Establishes a policy and procedure for Court's handling of the filing of a hazardous paper or thing.
9010-1(b)(4)(A)	44	Authorizes Clerk of Court to suspend an attorney's ECF filing privileges if the court receives notification the attorney is not authorized to practice law in the court. (I.e. suspension, disbarment, etc.)

Objections to Claim Noticing Process

Step Action

1 Movant files objection to claim.

Docket Event: [\[Bankruptcy> Claim Actions> Objection to Claim\]](#)

2 **Court** docket hearing notice; schedules certificate of service deadline.

Exception: Chapter 7 case assigned to Judge Ellington. A hearing is not scheduled instead the movant must provide a 30-day negative notice to the affected parties.

3 **Movant** - receives hearing notice.

Note: ECF registered users - via Notice of Electronic Filing (NEF). Non ECF registered users - via regular mail.

4 **Movant** serves the objection and hearing notice to the affected parties.

Note: If the objection is served prior to filing with the court it is only necessary to deliver/mail the hearing notice.

5 **Movant** files a *Certificate of Service* (the "certificate").

*Certificate must:

- Specify method of service
- Identify parties served
- Be filed with the court within three (3) days from date notice is docketed by the court.
