

# Paying Filing Fees After April 27, 2020

After the upgrade to NextGen ECF filers will pay filing fees through their PACER account.

Below is an example of the payment process, after the ECF user files a document and incurs a filing fee.

## Filing Fee Process


1. On the Internet Payments Due screen, click Pay Now
